

2019 Washington Youth Tour Contest Rules & Regulations

We select two high school students (junior or senior year) who will receive a full-expense paid trip to Washington, DC. Included are guided tours of the nation's capital and meetings with dignitaries from your congressional district. You will meet hundreds of youth from around the country and make life-long friends.

Eligible participants: Must be a junior or graduating senior for the 2018-2019 school year in a participating public/private school system or home school student in our service area. This contest is open to all seniors and junior regardless of electrical utility provider.*

Winners of the contest must be available to attend the Washington Youth Tour June 13-20, 2019. Any student who has previously won the Washington Youth Tour is not eligible to enter the contest a second time.

Letter Criteria and topic: Write a letter to the President of the United States explaining an energy related problem and outline your proposed solution. The letter should not be more than 500 words and should be typed, double-spaced on white paper and have a cover sheet with title and last four digits of their Social Security Number.** The letter should follow standard rules of grammar and composition and reference material should be documented. Independent judges will grade the letters.

Interview: Following the evaluation of written work, the top four applicants will participate in an interview. Interview judging criteria will include general knowledge of energy topic, poise, personality, professionalism, and speaking ability.

Due date: Letter and Participant Notification Form should be delivered to the sponsoring teacher, guidance counselor, or David Martin (Irwin EMC Coordinator) at Irwin EMC by **5 p.m. on March 1, 2019**.
